| 6. 《外国留学人员来华签证申请表原件》(JW201 或 JW202) 和学校录取通知书原件。 Original and photocopies of “Visa Application for study in China form” (JW201 or JW202 forms) and Admission letter issued by a school. | |
| 7. 经公证的体检表原件和复印件 (表格可从通知附件中下载) Original and photocopy of completed physical examination form notarized by a notary public. *Please download the physical examination form from appendix. | |
| 8. 奖学金证明, 自费生需要提供资金证明 (每个学年不少于 2500 美金) Scholarship certificate, non-scholarship students need to provide proof of funds or sponsors’ proof of funds (\$2,500 per academic year), sponsorship letter and photocopy of sponsor’s ID. | |
| 9. 非加纳籍公民申请签证, 还须提供: 有效期不少于半年的在加纳居留、工作或学习许可等正本及复印件。 For citizens of other countries, the following supplementary document are required: The original and photocopy of residence, work or study permit in Ghana with a minimum validity of six months of remaining. | |

注意：必要时，领事官员可视情要求申请人提供其他证明文件或补充材料，或要求与申请人面谈。领事官员根据申请人的具体情况决定是否颁发签证及签证的有效期、停留期限和入境次数。

NOTICE: If necessary, the consular officer may require the applicant to provide other proof documents (real estate documents, land documents , vehicle ownership documents or any property ownership documents)or supplementary materials , or require an interview with the applicant. The consular officer will decide on whether or not to issue the visa and on its validity, duration of stay and number of entries in light of specific conditions of the applicant.
